**ZONING HEARING BOARD:**

**RESIDENTIAL:**

In submitting an application for a residential appeal, special exception, variance, curative amendment, or other requested relief, a filing fee of \$500.00 is required.

In the event that the cost associated with processing the application to the Zoning Hearing Board or conducting the meeting shall exceed the \$500.00, the applicant shall be required to deposit additional funds in an escrow account to cover the additional cost

**COMMERCIAL:**

In submitting an application for a Commercial, Institutional or Industrial appeal, special exception, variance, curative amendments, or other requested relief, a filing fee of \$1000.00 is required

In the event that the cost associated with processing the application to the Zoning Hearing Board or conducting the meeting shall exceed the \$1000.00, the applicant shall be required to deposit additional funds in an escrow account to cover the additional cost
