Part 1**Recognition of Millbourne Fire Company****§7-101. Fire Company Recognized.**

The Millbourne Fire Company, organized and existing in the Borough of Millbourne, Delaware County, Pennsylvania, is hereby designated as the officially recognized fire company for the Borough.

§7-102. Authorized Activities of the Fire Company.

1. The Millbourne Fire Company as recognized by the Borough is hereby authorized to provide such services to the Borough as may be necessary for the protection of property and persons situate therein, which include, by way of example and not of limitation, the extinguishment of fires and prevention of the loss of life and property from fire, automobile accidents, medical emergencies, hazardous materials incidents, and other dangerous situations.

2. The Millbourne Fire Company may also provide non-emergency and public service functions, such as, by way of example and not of limitation, removing water from property after storms and assisting in the removal, abatement and prevention of damage or injury to persons or properties, through either natural causes or man-made situations.

3. The Millbourne Fire Company may also conduct and participate in such training activities and drills, either within or outside of the Borough, as may be deemed necessary or advisable by the officers of Millbourne Fire Company to maintain proficiency in providing the authorized activities and services.

4. The Millbourne Fire Company may also respond to calls and provide services to municipalities outside of the Borough pursuant to mutual aid agreements.

§7-103. Authorized Activities of Members of Fire Company.

1. In addition to participating in the activities of the Millbourne Fire Company as authorized above which include proceeding to and returning from such activity or activities, the members of the Millbourne Fire Company are also authorized to do the following:

A. Engage in any type of drill, training, ceremony, practice, test, or parade when duly called for or authorized by an appropriate officer of the Millbourne Fire Company.

B. Engage in fund-raising activities for the Millbourne Fire Company when duly authorized by an appropriate officer of the Millbourne Fire Company.

C. Engage in the performance of any other duty or activity when duly authorized by an appropriate officer of the Millbourne Fire Company.

§7-104. Purpose.

The purpose of this Chapter is to recognize the Millbourne Fire Company as the official fire company of the Borough and to state additional, authorized activities for the firefighters for purposes of Workers' Compensation.
